

There were 92 responses recorded out of which 20 teachers were Associate Professors and the rest 71 were Assistant Professors. Q.1 Does the course content fulfil the needs of students?




40% of the respondents **Strongly Agreed** that the course content fulfils the need of the students.

Q.2 Good facility and encouragement to the teachers for their research and other academic work?




31% of the respondents **Strongly Agreed** that there is good facility and encouragement to the teachers for their research and other academic work.

Q.3 College has adequate facilities and is equipped to handle major emergencies?




33% of the respondents **Strongly Agreed** that college has adequate facilities and is equipped to handle major emergencies.

Q.4 Authorities are approachable and accessible?




43% of the respondents **Strongly Agreed** that the authorities are approachable and accessible.

Q.5 Staff rooms, toilets and classrooms are clean and well-maintained?




45% of the respondents **Strongly Agreed** that staff rooms, toilets and classrooms are clean and well-maintained.

Q.6 There is a recognition/incentive/appreciation of the individual achievements by the authorities?




31% of the respondents **Strongly Agreed** that there is a recognition/incentive/appreciation of the individual achievements by the authorities.

Q.7 Does the college have a good network of CCTV cameras covering all the important areas of the campus?




42% of the respondents **Strongly Agreed** that the college does have a good network of CCTV cameras covering all the important areas of the campus.

38% of the respondents **Strongly Agreed** that the college canteen provide nutritious and hygienic food.


47% of the respondents **Agreed** that the college canteen provide nutritious and hygienic food.
