However, if the firm quotes Service Charges @ 1% or less, which correlates to an unrealistic consideration, will also be treated as non-responsive and will not be considered. Service charge must be calculated on (Basic wage rate+ESI+EPF).	The instructions issued vide OM No. 61112023-PPD dated 06.01.2023 have provides only for prescribing minimum service charges in the range from 3.85% to 7 % in the tender documents. There is no bar in these instructions on award of tender to lowest bidder, if he has quoted service charges more than service charges prescribed as minimum service charges (i.e. 3.85% to 7%).
