Frequently Asked Questions (FAQs) about the Admission Process

Q:1 After registering online on the Delhi University site, do aspirants need to fill offline forms as well?

- A:1 No, there is no offline form.
- Q:2 Will the applicants be given on a first-come-first serve basis after declaration of cut-off?
- A:2 Admissions won't be based first-cum-first serve basis. Aspirants have to meet the cut-off criteria for a particular course and then will be considered for admission as per the schedule.
- Q:3 Can the details in the application be edited?
- A:3 Yes, but only primary fields like name, date of birth, gender cannot be changed once it is entered and submitted.
- Q:4 Can the online registration form be submitted if the results are awaited?
- A:4 Yes, the form can be submitted and the candidate needs to choose the option 'awaited' under the result status.
- Q:5 I did not have Mathematics in class XII. Can I opt for B.A. (H) Economics, B.Sc.(Hons.) Computer Science, & B.Com. (Hons.)?
- A:5 No you cannot opt for Economics (Hons.), B.Com.(Hons.) & B.Sc.(H) Computer Science without having studied Mathematics in class XII.
- Q:6 Will there is a disadvantage for gap-year candidates?
- A:6 No, there is no disadvantage to gap year students and they will be treated at par with regular students. They should meet the requisite course-specific criteria for admission and must possess the necessary documents/certificates.
- Q:7 Can candidates pursue two courses at the same time from different colleges in Delhi University?
- A:7 No, only one degree course can be pursued at a time. However, candidates can enroll in a diploma course from another college simultaneously.
- Q:8 Will there be a centralized Sports/ECA trial?
- A:8. Yes, there will be centralized Sports/ECA trials to be conducted by the University of Delhi.
- Q:9 Is ECA and Sports quota applicable to courses where admissions based on entrance test?
- A:9 No, ECA and Sports quota are not applicable to courses where admission is based on entrancetest.
- Q:10 Is it possible to get admission in Business Economics and B.M.S. on merit basis?
- A:10 No, the admissions of Business Economics and B.M.S. will be done only Entrance basis.
- Q:11. Is it important to have caste or tribe certificate in the name of the applicant?
- A:11. Yes, if you are applying under any reserved category, then you must have the relevant reservation certificate issued by the competent authority, in the name of applicant. The OBC certificate must also specify that applicant belongs to non-creamy layer and the caste is listed in the Central Government list. The validity of the non-creamy layer certificate shall be for the financial year 2020-21, issued after 31st March, 2021.

Q.12. What are the criteria for change of college/course, if already admitted in another college of Delhi University?

A:12. If, in subsequent list, you find yourself eligible for admission to this college/course, you should ensure your eligibility by visiting the college. Please ensure that you qualify cut-off in the college you wish to shift to by checking in person before you cancel your previous admission through the online portal. Once cancelled, you cannot be re-admitted in the eventuality that you do not secure admission in the next college/course.

Q:13 Should I pay admission fees again to this college?

A:13 No, the fees will be adjusted automatically and you have to pay only the balance fee if it is more than the fees already paid at the previous college. If the fee is the latter college is less, the balance will be refunded to your account or to an account declared by you, as per the Delhi University rules after the admissions are closed.

Q:14 How is the fee supposed to be paid and how much time do I have to pay the fee?

- A:14 After the final verification of documents, applicant is required to pay the fee within the time limit as per DU guidelines. Generally, the deadline to pay the fee is within 24hours of final verification of documents. Applicant can pay his/her fee online by logging onto DU portal.
- Q:15 How can I get my original certificate from previous college to get admission in your college?
- A:15. You do not have to submit the original certificates, at the time of your admission, only your original certificate is shown to you for verification at that time, after that you will return your certificate and a set of self-attested photocopies of it will be deposited.

Q:16 Does College offer hostel facilities?

A:16 No the hostel facility is not available in this college.

Q:17. When will I be able to get my Identity card after the admission?

A:17 You will be able to get the College Identity Card only after the college starts, till you get the College Identity Card, then you will only enter the college by taking a fee slip. No one will be permitted to enter the college without fee receipt till identity card is issued.

Q.18. When will the classes start?

A:18 All the classes will start on 1st day of beginning the session for the academic year i.e. 2021-22. In this regard the academic calendar also available on the Delhi University website du.ac.in. The college will also notify the Orientation Programme on the college website.
