### UNDERTAKING AND DECLARATION BY THE CANDIDATE

2. I undertake to reply to all the notices sent to me in my email ID/Whats App Message/Text Message mentioned above within 24 hours failing which the Patron Student's Council may take Ex-parte decision on the validity of my candidature.
3. I undertake to submit with the College, in person, all relevant documents.
4. I undertake to submit in person the nomination papers with Bank Draft for Rs. 500/- (Rupees Five Hundred only) in favour of the Principal Aryabhatta College in the office of administration as security deposit.
5. In case, I fail to secure 10% of the valid votes cast, I shall forfeit the security deposit of Rs. 500/-.
6. I solemnly declare that:

  - d) I have not been found guilty of, and punished for the use of unfair means in any examination of the University or Board.
  - e) I have attained the minimum classroom attendance i.e., 75% in my preceding year of the Course.
  - f) I have no academic arrear i.e., to say that there are no pending papers to be cleared by me and my marks percentage is as per the eligibility required for the post I am contesting.
7. A candidate shall contest for only one post, in case nomination form is filled for more than one posts candidate should withdraw all except one, otherwise candidature will be cancelled.
8. I undertake to submit that I will be contesting and campaigning for my candidature as an individual only and will not campaign & canvass my candidature as member of any group or for any group of students as stipulated in the Lyngdoh Committee report.
